

Privacy Policy

Thank you for visiting the CITIZENS FOR THE FUTURE OF COLLIN COUNTY website and reviewing our privacy policy. We are committed to ensuring the privacy of all our web site users. This document explains our collection and use of personal information.

CITIZENS FOR THE FUTURE OF COLLIN COUNTY does not collect personal information about individuals without their knowledge. Personal information may be requested when you engage in any of the following online activities:

- Use Email.
- Submit information to the site via a form. This includes activities such as completing a feedback form or an online application.

Use of Personal Information

We do not collect any personal information unless you voluntarily provide it by sending us e-mail, participating in a survey, or completing an on-line form. Personal information submitted will not be transferred to any non-affiliated third parties unless otherwise stated at the time of collection. When a user submits personally identifiable information it is used only for the purpose stated at the time of collection.

Email

If you send us an electronic mail message (email), the message will usually contain your return email address. If you include personally identifying information in your email because you want us to address issues specific to your situation, we may use that information in responding to your request. Remember that email is not necessarily secure against interception. Please send only information necessary to help us process your request. If you send email to us, it will be forwarded to those individuals (employees, school board members) necessary to address that e-mail.

Email Lists

The information we collect when you subscribe to one of our email lists is used solely to administer these lists and is not shared, disclosed or sold to other organizations. Users who no longer wish to receive our notifications may opt-out of receiving these communications by sending an email to webmaster@collincountybonds.org.

Links to Other Sites

The CITIZENS FOR THE FUTURE OF COLLIN COUNTY website provides links to other websites. CITIZENS FOR THE FUTURE OF COLLIN COUNTY is not responsible for the privacy policies of other websites, and CITIZENS FOR THE FUTURE OF COLLIN COUNTY's privacy policy does not apply when you visit these other sites. We recommend that you be aware when you leave our web site and encourage you to read the privacy statements of other websites you visit.

Anonymous Information - Log files

Our website will automatically record some broad demographic information, such as a visitor's country, operating system, browser types, frequency of visit, and so on. This tracking system does not record information about individuals. We use this information for statistical analysis, to help us make our site more useful to visitors. The information is not reviewed on an individual basis but is aggregated with other users for comparison purposes.

Cookies

A "cookie" is a piece of data stored on the user's hard drive containing information about the user. It enables CITIZENS FOR THE FUTURE OF COLLIN COUNTY to store and track what you are looking at when you visit the CITIZENS FOR THE FUTURE OF COLLIN COUNTY site. If you are concerned about the potential use of information gathered from your computer by "cookies," you can set your browser to prompt you before it accepts a "cookie." Most Internet browsers have settings that allow the identification or rejection of "cookies."

Security

CITIZENS FOR THE FUTURE OF COLLIN COUNTY takes reasonable precautions to protect

your personal information. When you submit information via the website, it is protected both online and off-line. When personal information is required, that information is stored in a secure file on our server. We also take precautions to protect user information off-line. All user information is restricted to authorized employees. Only employees who need the information to perform a specific task are granted access to personal information. The server used to store personal information is kept in a secure environment.
